Our editing process attempts to strike a balance between retaining the spirit of the Conference and maintaining the *Journal*'s overall readability. We have strived to make this volume of the *Journal* the best-edited and most carefully-researched volume in the Institute's nearly 30-year history. The text generally conforms to the *Chicago Manual of Style* (14th ed.).
