

I am giving you copies of my transcriptions of the thirteen interviews conducted to date by Professor Emeritus Oliver Schroeder as part of an oral history of the law school. A fourteenth transcription is of my own interview with Mary Bohurjak; I also give you the cassette tape.

I am also giving you a disk containing the transcriptions, all in WordStar 3.

Finally, I give you some pages that Professor Schroeder turned over to me: his notes on the David Ford interview, photocopied material about Henry DuLaurence Sr., a memorandum and biography from Lisle Buckingham, and a photocopy of a little article that Mr. Buckingham read into the tape recorder.

A separate sheet catalogs the interviews.

A word about my transcriptions. They are perhaps 99 percent accurate. I did not capture every false start of a sentence, for example, or every comment interjected by the interviewer. And I have not attempted to verify the proper names; sometimes (but not always) an uncertainty is indicated by a question mark. Anything in square brackets is an insertion by me.

A peculiarity of my word processor is that when I make a dash with two hyphens—like this—and it happens to fall at the end of the line, the two hyphens don't necessarily stay together. You—get something that looks like that when it's printed. I did not attempt to correct the problem when I printed the transcriptions because I didn't want to introduce extra spaces or returns.

By agreement with Dennis Harrison, I'm also giving copies to the university archives.
