
Dear Coddingle Realty LTD,

On November 14, 2016, the Division of Oil and Gas Resources Management ("Division") issued Chief's Order No. 2016-386 to Coddingle Realty LTD. Chief's Order No. 2016-386 found Coddingle Realty LTD committed a material and substantial violation for failure to maintain insurance coverage, suspended Coddingle Realty LTD oil and gas operations in the State of Ohio, and required Coddingle Realty LTD to file proof of insurance with the Division within thirty days.

On December 01, 2016, the Division received proof of liability insurance from Coddingle Realty LTD. Therefore, the Division finds that Coddingle Realty LTD is in compliance with Chief's Order 2016-386 and the order is terminated by this letter.
