 called her yesterday.

 job was important. Finally was  
 sex discrim in agency prof harassment.  
 XX - no final agency decision

Devera Murray. while in Newark  
 talked to Prinson. reputation -  
 on occasion worked w. Prinson.  
 worked w. Diane. Eddy's was  
 liked young pretty girl, dating  
 girls who she worked with.  
 Wilkins very captent. (secretary).  
 wouldn't sign affidavit -- wanted

work w. worked w. her on various.  
 Took from lunch w. girls from  
 agency. Never saw him talk  
any woman in office. Nat  
led her during P. Reputation  
based on rumors? yes.

Did you like Ellen Bevil? liked  
 her ok. liked Anita Farnett.  
 thought she deserved a promotion



didn't get it. Gave Perriol  
 promotion. Resented it? No.  
 No promotion not trying to do w. it.  
 Don't remember M.S. Periol.  
 after rejected press criticism.

Never observed press or heard  
 mistreatment. Never made  
 press at her or see any press  
 rare in her presence.

+ divorce. Said in Dec.  
 couldn't leave because of isid.  
 Resumed after not seeing for some  
 time. Continue w/o marriage.  
 when -- offer to continue rel.  
 when don't recall. After Jan '72,  
periodically saw each other. saw  
each other more + more. March  
'72. once or twice a week, 7 pm  
 until 11. or 1 or 2 am. Jan '72 -  
 March '72. still seeing him.  
 after March '72. continued  
 for fairly long time different  
 levels of frequency. late '72  
 stopped except twice to four  
 '73 after left. Decreased
