SUBJECT: Termination of Appeal and Request for Stay of Execution

I have been notified by Ohio Oll and Gas Commission Executive Director Linda Osterman and Ohio Assistant Attorney General Daniel Martin, in a telephone conversation on April 8, 2014, that Ohio Department of Natural Resources, Chief of Oil and Gas Resources Management, Richard Simmers, has revoked Mandatory Pooling Order No. 2013-182 concerning the Everflow Eastern Partners L.P.
