My compliments on your preparation of the Draft Minutes. Considering the length of our sessions and complexity of the arguments, they are very well done.

- 1. I have one suggested deletion which the Chairman and Commission members will have to decide on. That is the unpleasant exchange at the Third Meeting, Tuesday, December 5, 10:00 a.m. session, and the resumption at 10:55. I feel that it is unnecessary to include that in the minutes and suggest its deletion as per the enclosure.
- 2. There are a few omissions (unless they escaped me, in which case, please advise me):
  - A) The Chairman mentioned (I believe at the first session) an offer of personnel assistance from the United States and a meeting with Ambassador Abrams. It should be noted.

- B) The Chairman (I believe at the last session) appointed me to represent the Commission on the question of an international criminal court and asked that I be in contact with Ambassador Corell and the CSCE Committee. The Commission supported the Chair. It should be stated explicitly.
- C) President M'Baye (I believe on the second day) moved and the Commission approved that I be designated Rapporteur on data gathering and analysis. It should be stated explicitly.

That is all I have except for one stylistic word change at the sixth meeting.
