was reached before June 30, 1966, the end of the University's fiscal year. The Law Alumni Fund is becoming increasingly important in meeting the basic needs of the School and has been directly responsible for providing much of the monies needed for scholarship and student aid. As we attract more top students, we must continue to maintain a position of being able to hold these highly qualified young men and women.

Vital to the health and financial wellbeing of any private institution of higher learning are the interest, enthusiasm and loyal support of its alumni.

In areas of library, equipment and faculty needs, the Alumni Fund has been of great value. The Law School is moving ahead rapidly and following growth plans that include increasing the number of full-time faculty. There will be 14 such men in September of this year. The Alumni Fund also helps maintain the Alumni Association (\$2 of each gift) and includes a subscription to the Western Reserve Law Review.

The average gift is close to \$45, a record for this fund.

Most significant is the record alumni participation in this year's Law Fund.

Thanks to the wonderful support of alumni over the past several years, our Law School has overcome many crises and can again hold its head up as a true leader among law schools. We do not believe any school could accomplish more than the following in one year:

1—Obtain the services of a man of the caliber of Louis A. Toepfer of Harvard as our new dean.

2—Undertake and complete the Bok report, a comprehensive study and analysis, by top professional men, on the status of the school, with recommendations on all phases of its future activities and with the approval of the school officials on every major point.

3—Bring a new law school building out of the dream status into a promised reality within the immediate future.

4—Bring our faculty up to proper strength in both quantity and quality and guarantee that there are sufficient funds to pay the necessary salaries.

5—Through the use of the major part of our contributions, set up a scholar-ship program superior to many law schools, and resulting in a substantial increase in enrollment, again, both in quantity and quality.

In light of these tremendous accomplishments, the Board of Trustees raised our goal to \$60,000 this year, knowing that the generosity of our alumni does not have to take a back seat to any other law school in the country in percentage of alumni participation or size of average gift.

He said ideas about class sizes and space needs are being developed.

Dean Toepfer drew laughs when he described himself as the only dean with the keys to two law schools—Harvard and WRU—yet every time he opens his house door he is obliged to use a "Yale" key.







Dear Oliver:

I have just received the Law Alumni Review (Fall, 1965) and am delighted that your hopes of getting Dean Toepfer have been realized . . . I thought you might be interested in knowing that we have now established a Family Court whose function will be to deal with exclusively in those legal matters involving family relationships. All matters relating to adoptions, custody, modification of previous orders, reciprocal support and conciliation matters have been centered in one department on a one-year assignment.

Because of my many years of involvment in social service agencies, I have been designated as the first Judge of this Court. We are, in addition, studying the feasibility and, hopefully, will put into action a Conciliation Court system with qualified marriage counselors employed by the Court and under the direction of the Family Court Judge.

I am delighted that enrollment is increasing and it appears that the Law School is finally going to emerge from the old building into proper facilities.

in criminal and admiralty law there. A native of Sheboygan, Wisc., he received his B.A. from Beloit College and earned his LL.B. from Harvard after serving with the Navy during World War II. (For additional background data on Dean Toepfer, see Law Alumni Review, Fall, 1965.)

Dean Toepfer feels WRU's School of Law is a remarkably fine school, growing in size and stature. "It's now on the threshold of development, growth and change, as is the entire University."

He is especially interested in reasons why some students decide to attend law school while others decide against it. He plans to make young people aware of the presence of WRU's law school and of the opportunities it has to offer. In this connection, he plans to visit colleges around the country.

While both the government and law firms need more and more lawyers, law schools haven't increased their output very much in the last 50 years, Dean Toepfer noted. "We're turning out only 50 lawyers per million of our population." With more and more financial aid becoming available to them, law students are beginning to look upon law as a profession with a kind of nobility and a chance to serve humanity, he believes.

Referring to legal education as the queen of academic disciples at a luncheon in his honor in Cleveland, Jan. 6, 1966, Dean-elect Toepfer left this thought with his audience:


