### Dear Ralph:

- 1.) Attached please find an update on the Annexes.
- 2.) I expect the following Annexes to be completed on 21 or 22 June: I, I.A, I.B, I.C, II, III, IV, VI, VI.A, VI.B, VII, IX, IX.A, X, X.A, X.B, XI, XI.A, and XII. They will be immediately sent to Graham Blewitt.
- 3.) The remaining Annexes, III.A and VIII, will be completed in Chicago by the end of June.
- 4.) Annex V is to be prepared by Ms. Greve, but we are unable to reach her. Julio was supposed to be following up on this one when he was in Geneva, but was obviously unsuccessful. I will try to reach her.
- 5.) For your information, Annex XI, Judge M'Baye's report, was edited by Mrs. Molina in French instead of English, despite my request to do it in English. The same is true of Lt.-Col. Kim Carter's report which Fenrick submitted. We have redone both in English.
- 6.) Thank you for sending me Fenrick's latest fax. Julio was assigned to edit his reports. One of the problems with the edited version that I received is that Fenrick lumped everything into a single report,

notwithstanding the topical divisions based on the list of Annexes. As a result, we are now in the process of separating them in accordance with the schedule of Annexes. In so doing, we are going to have to cut out the many pages devoted by Fenrick to the description of what he did and how he did it. We had discussed not including many pages on methodology, preparation of missions, and other organizational and logistical matters. I can understand Fenrick's desire to include such details. However, because of the size of the Annexes and their specific focus, we cannot give much space to such matters.

- 7.) Do you want me to send the Annexes as they are completed or wait to give you the whole set at one time?
- 8.) I trust that this gives you an updated and completed progress report on what is being done.
