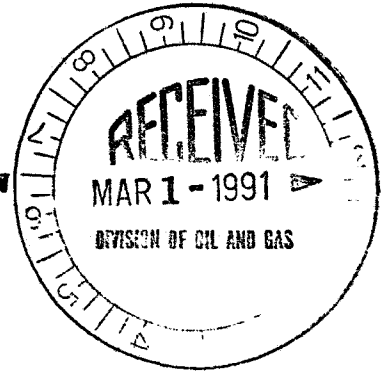




ENTRY AND ORDER


