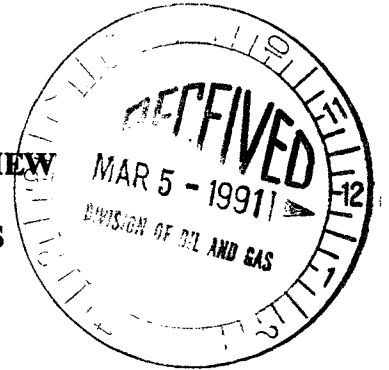
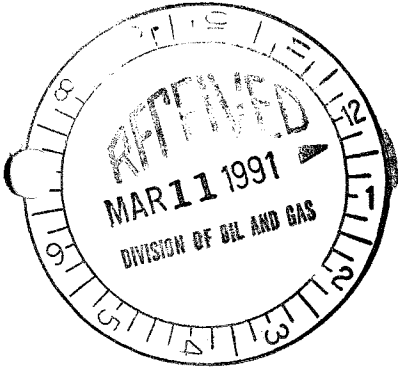

SETTLEMENT AGREEMENT AND JOINT NOTICE OF WITHDRAWAL


Now come appellant Redman Oil Company and appellee Chief of the Division of Oil and Gas and hereby jointly notify the Oil and Gas Board of Review that the instant appeal, Appeal No. 431, has been jointly resolved as follows:

- (1) Upon the filing of this settlement agreement, the parties jointly withdraw Appeal No. 431;
- (2) Upon the filing of this settlement agreement, the Chief of the Division of Oil and Gas shall amend Chief's Order No. 90-677, which is the subject of this appeal. A copy of amended Chief's Order No. 90-677 is appended hereto and incorporated by reference as if fully re-written herein;

- (3) Appellant Redman Oil Company hereby waives its right to appeal Amended Chief's Order No. 90-677, referred to in ¶2 of the instant settlement agreement;
- (4) Nothing in this Settlement Agreement and Joint Notice of Withdrawal shall be construed as an admission of any violation of Ohio law upon the part of appellant Redman Oil Company. Nothing in this Settlement Agreement and Joint Notice of Withdrawal shall be construed to limit the right of the Division of Oil and Gas to issue other decisions and orders and to enforce R.C. Chapter 1509 and the rules promulgated and orders and terms and conditions of permits issued thereunder.
