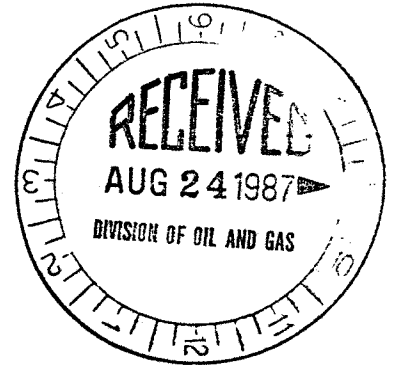

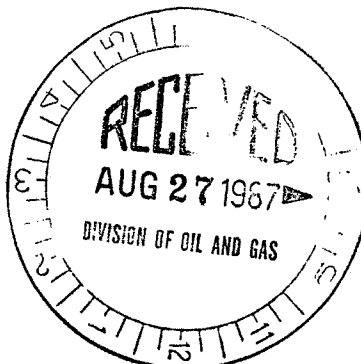

3. Appellant waives its right to appeal Amended Order No. 87-272 referred to in paragraph two (2) of this settlement agreement.


