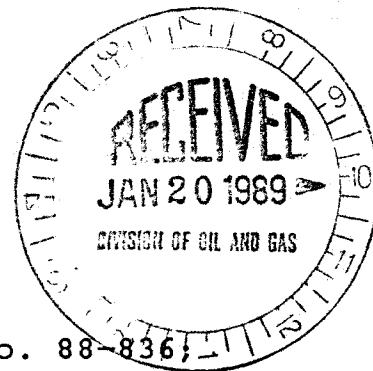



The Appellant has been notified by the Enforcement Coordinator of the Division of Oil and Gas that the required action to gain compliance with the above-captioned orders has been taken.


IT IS THEREFORE ORDERED that Appeals Nos. 310 through 318 are hereby dismissed.






ENTRY FOR DISMISSAL

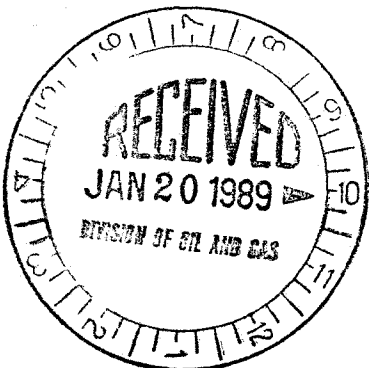
