





Regarding Chief's Order 2018-124

On June 27, 2018, the Division of Oil and Gas Resources Management ("Division") terminated Chief's Order 2018-124 ("Chief's Order"), the Chief's Order subject to Appellant's appeal. Even though the Division was aware that Appellant was represented by counsel, the Division sent the Notice of Termination of Chief's Order No. 2018-124 directly to Appellant. The Division did not notify Appellant's counsel, the Division's own attorneys, or even the Oil and Gas Commission of the termination of the Chief's Order. As the Chief's Order was terminated by the Division, this appeal is therefore moot and is hereby withdrawn.
