INTRODUCTION

EXTRATERRITORIAL SANCTIONS IN THE CANADA/U.S. CONTEXT

We shall start the second day of this intellectual feast with a subject that is very dear to many hearts, or disliked in many respects by many more people. It is extraterritorial sanctions in the Canada/U.S. context and here we have two outstanding speakers. They have agreed between themselves that Barry Campbell, who is our Canadian speaker, will go first.

Barry has served as a Member of the Parliament of Canada from 1993 to 1997. Barry served for two years as vice chair of the House of Commons Standing Committee on Finance, and two years as chair of the Greater Toronto Federal Liberal Caucus. From January 1996 to June 1997, he served as Parliament Secretary to the Ministry of Finance. Prior to his election to Parliament, Mr. Campbell was with the Toronto firm of Tory, Tory, DesLauriers & Binnington where he advised major Canadian and foreign clients on acquisitions, international mergers, international banking matters, and competition and trade law.

Barry Campbell, at one time, was legal counselor at the International Monetary Fund in Washington, and then practiced in the Washington law firm of Arnold & Porter. He graduated from McGill University, McGill Law School, and Harvard Law School. Currently, he is chairman of APCO Canada which is a public affairs and strategic communications company. Barry Campbell comes highly recommended. He has attended our conferences before and it is indeed a pleasure to present him to you today.

Arthur Downey, our U.S. speaker, is a very old and very dear friend of mine. He is Vice President - Government Affairs of Baker Hughes, Incorporated, a Fortune 500 company headquartered in Houston, Texas. Mr. Downey is based in the Washington office of Baker Hughes. Prior to joining Baker Hughes, Mr. Downey was a partner in a major Washington law firm, was Assistant Secretary of Commerce, and was a member of Henry Kissenger's National Security Council staff. He also served in the State Department in Washington, D.C. and Berlin, Germany, and was an adjunct professor of law at Georgetown University.

He is a member of the President's Export Counsel Subcommittee on Export Administration and is a member of the Board of Directors of the American Drug Company. He received his J.D. from Villanova University and his LL.M. from Georgetown University.
