Pursuant to a recent global settlement agreement between Appellant Clewell Family Farm, LLC and operator Chesapeake Exploration, LLC, Appellant hereby withdraws all subpoenas issued to the Chesapeake entities in the above-captioned appeals. Appellant hereby withdraws with prejudice Appeal No. 862 filed with the Commission on February 28, 2014, which pertains to Order No. 2014-46, issued on January 29, 2014 by the Chief of the Division of Oil and Gas Resources Management, Ohio Department of Natural Resources (the "Chief"). Appellant also hereby withdraws with prejudice Appeal No. 928 filed with the Commission on June 15, 2016, which pertains to Order No. 2016-161, issued by the Chief on May 18, 2016.

Accordingly, Appellant Clewell Family Farm, LLC respectfully requests that the Commission dismiss with prejudice Appeal Nos. 862 and 928.


