




Upon Joint Notice of Withdrawal filed by Appellant, the Board HEREBY DISMISSES Appeal No. 552 with prejudice.

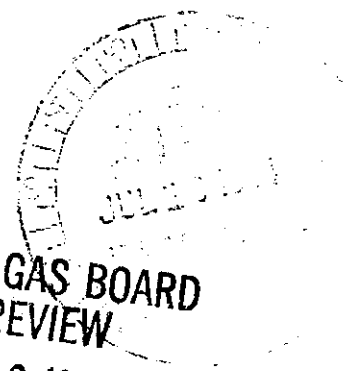


