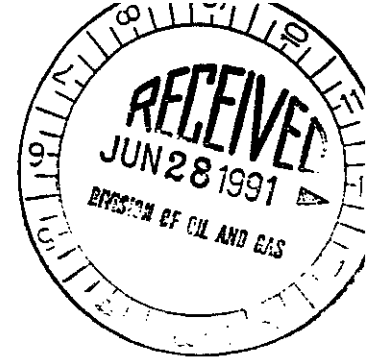


89-822, which is the subject of this appeal. A copy of the amended order is attached as Exhibit "A" and incorporated herein by reference;



The Chief of the Division of Oil and Gas ("Division") having given due consideration to the matter contained herein makes the following Findings:


FINDINGS:
