EDITORS' PREFACE

This issue marks the beginning of Volume 17 of the *Review*. The Board of Editors has made certain changes, most notable of which is that the volumes will now conform to the academic year, thus reflecting the change in editorial staffs. With five issues per academic year, the publication schedule will be bimonthly from October through June. The annual index and title page for the bound volume will accompany the June issue.

The synopses before each lead article have been added because it was thought that they are not only convenient for the reader but also serve as a useful research tool. Prepared by the editorial staff, they attempt both to summarize the article and to indicate the author's position on the points discussed.

A "Cases Noted" section has been added to provide coverage of new decisions which, because of space limitations, could not be given full treatment in a "Recent Decision." No attempt is made to do anything more than briefly summarize the facts of the case and the holding of the court.

The December issue, which will be distributed in January, will be a symposium issue dealing with abortion and the law. This extremely timely subject will be explored and discussed from the viewpoint of law, medicine, religion, and sociology.

Finally, because of increasing publication costs and the expansion to five issues per academic year, the subscription price, beginning with Volume 18, Number 1, October, 1966, will be increased to \$7.50 per year. In addition, single issue prices were increased to \$2.50 per copy effective, November 1, 1965.
